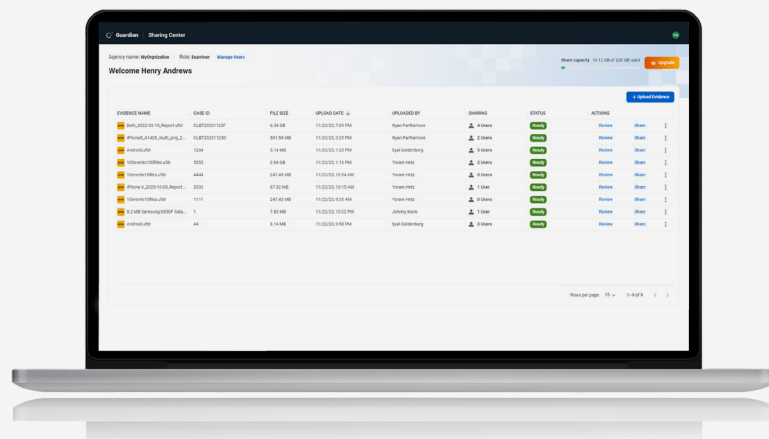


Guardian Starter



Functionality Overview

Welcome to Cellebrite Guardian Starter. Starter bridges the process between digital forensics units and investigative units, helping you accelerate your examinations simply and securely. Share UFDRs in real time directly from your Physical Analyzer, desktop or browser and enable case stakeholders to review evidence immediately, right from their browsers.

We are excited to offer Cellebrite Guardian Starter at no cost, with no obligation. Starter is the first of the Guardian offerings. Each tier is built to meet the different needs across DFUs and law enforcement stakeholders, so that you can choose the right Guardian for your requirements and scale.

Guardian is a Software as a Service (SaaS)-based solution; leveraging the speed, accessibility and security of public cloud technology and is powered by AWS GovCloud.

Guardian Starter consists of the following main modules:

- **Desktop Uploader** – Streamline sharing by integrating Guardian Starter with Physical Analyzer or directly from your browser.
- **Web-Based Sharing Center** – Review all files shared with you, share with others and review UFDRs.
- **Web-Based UFDR review** – Intuitive and instant web-based review module.

Guardian Starter addresses the following functions:



Uploading and Sharing

Starter gives you several options to simply, securely and quickly upload and share evidence with stakeholders:

- **Physical Analyzer**
Simply click “share” when you generate a UFDR report or from your Report History.
- **Sharing Center**
Log in to your account and share files from within your browser.

- **Uploader**

Drag and drop UFDR files straight from your desktop.

- To get started with Guardian Starter, users must activate the Cellebrite Uploader, a desktop module that you can [access here](#).
- Simply:
 1. Click the link above to download the zip folder;
 2. Once downloaded, extract all files;
 3. Double click the “Cellebrite Uploader Setup” file to install the Uploader;
 4. Double click and run the .batch file to integrate Uploader to your Physical Analyzer;
 5. Start sharing!
- This module enables examiners to integrate the Guardian Starter offering with their existing Physical Analyzer to streamline their sharing processes.
- Once installed, users can upload UFDRs within Physical Analyzer for automated sharing, within their browser or from the Uploader, with a simple drag and drop, and adding in case ID, users to share with and any accompanying comments. Users can rename the file after it has been selected to upload and share.

You can share up to 200 GB of UFDRs per Physical Analyzer license. Once you reach your limit, you can manage space by deleting older files or upgrading your Guardian package to get more space.



Creating Users and Managing Access

You can set up new users in the following ways:

- **Using the Admin Portal**

Examiners can use the Admin Portal to:

- Create and remove users
- Manage and assign user roles. The roles are divided into:
 - System Administrators – All permissions. *More options coming soon.*
 - Examiner – Upload, share, review, manage users.
 - Investigator – Review, share, and invite unlisted users.
 - Reviewer – *Coming soon.*
- Review user status
- Resend invitations, if needed

- **Invite While Sharing Evidence**

All users can invite new users while sharing evidence simply by adding a contact’s full email address. All unlisted users added during the sharing process will be assigned the “Investigator” role by default. Once a user has signed up, Administrators can complete user setup.





Reviewing Evidence

Guardian Starter enables users to review UFDRs using an advanced web-based review module. Downloading UFDRs is not included in Starter.



Email Communication

To foster ongoing collaboration and awareness, Guardian Starter automatically sends the following emails:

- User invitations
- Evidence upload status
- New evidence for review
- Printable report ready to download



Updates

Cellebrite Guardian leverages its SaaS-based architecture and does not require any updating from its users to ensure ongoing serviceability. Updates and fixes are provided automatically in rapid iterations. However, Uploader users will occasionally receive in-app notifications prompting them to download the latest version, since this is a desktop module.

Package Upgrades:

Starter focuses on simplifying and accelerating the share and review of UFDRs. Upgrade to other [Guardian packages](#) to upload, download, share and review in a vendor-agnostic solution and to streamline and manage your lab processes and evidence.
